COMMISSION OF THE CITY OF ROLLING HILLS GRANTING APPROVAL OF A SITE PLAN REVIEW FOR GRADING OF PATHWAYS ON A PROPERTY WITH A RESTRICTED DEVELOPMENT CONDITION IMPOSED THROUGH A PRIOR PROJECT IN ZONING CASE NO. 920 AT 37 CHUCKWAGON ROAD. (LOT 19-CF) ROLLING HILLS, CA. (VAN NORTWICK). THE PROJECT HAS BEEN DETERMINED TO BE CATEGORICALLY EXEMPT PURSUANT TO THE CALIFORNIA ENVIRONMENTAL QUALITY ACT (CEQA).
- RESOLUTION NO. 2017-08. A RESOLUTION OF THE PLANNING В. COMMISSION OF THE CITY OF ROLLING HILLS GRANTING APPROVAL OF A SITE PLAN REVIEW AND VARIANCES FOR GRADING TO RETAIN AS BUILT PATHS, RETAINING WALLS, PARITALLY OR ENTIRELY IN SETBACKS AND WHICH AVERAGE OUT TO MMORE THAN 2.5' IN HEIGHT, TO REPAIR RUPTURED STORM DRAIN PIPE AND TO REMEDIATE FAILING SLOPE; TO CONSTRUCT A BASEMENT A PORTION OF

WHICH WOULD ENCROACH INTO THE FRONT YARD SETBACK, TO REMOVE A BARBEQUE AREA WITH A RETAINING WALL AND RETURN THE SLOPE TO THE ORIGINAL CONDITION AND TO EXCEED THE MAXIMUM PERMITTED DISTURBANCE ON THE LOT IN ZONING CASE NO. 916 AT 5 EL CONCHO LANE (LOT 10-GF), ROLLING HILLS CA, (DE MIRANDA). THE PROJECT HAS BEEN DETERMINED TO BE CATEGORICALLY EXEMPT PURSUANT TO THE CALIFORNIA ENVIRONMENTAL QUALITY ACT (CEQA).

A. ZONING CASE NO. 897-MODIFICATION. Request for a modification to a previously approved project. The Modification entails a CUP to construct an 800 square foot recreation room, whereas 705 square foot recreation room was previously approved and to construct a water slide, in Zoning Case No. 897- Modification at 2 Hillside Lane, (Lot 60-RH), Rolling Hills, CA (Elkin). No changes are proposed to remaining previously approved entitlements, such as Site Plan, Variances and Stable Use Permit. The project has been determined to be exempt from the California Environmental Quality Act (CEQA) Guidelines, Section 15303.

Request to modify a previously approved project and request for a Site Plan Review for grading and Variances to allow import of dirt and to construct slopes that would be steeper than 2:1 gradient, in Zoning Case No. 923 at 38 **Portuguese Bend Road**, (Lot 118-RH), Rolling Hills, CA. (Wheeler). The project has been determined to be categorically exempt pursuant to the California Environmental Quality Act (CEQA).
